#### Update on JRP-2023

- WG members started the meeting by watching the JRP launch main video and the ISCG External Relations Coordinator gave update on the JRP-2023 launch that has been organised on 7th March in Geneva. He also briefed WG members on the outlook of the trends in donor funding in the coming term. Decreasing donor funding is a serious issue and it already reflected itself on WFP's recent food ration cuts. WG members have been encouraged to read key messages on JRP and WFP ration cuts.
- Consequently, we are likely to see some changes in the narratives and advocacy lines of all relevant actors in the coming term: Donor community, humanitarian community and the government - on some areas of four aspects of the response: Development, humanitarian, human rights and political.

#### Presentation on Financial Analysis

- ISCG Policy Officer Rewa El Oubari gave an update on the Financial Analysis regarding the overall Rohingya humanitarian response in 2023. A one pager summary of financial messages will be distributed separately.

#### Update on Fire Response in Camp 11

- ISCG Communications Office Syed Md Taffim gave an update on the [Fire Response in Camp 11 as of 16th March](#). WG members are encouraged to be acquainted with messages regarding pre, during and after fire/disasters. "To build back better" is the tagline for the all phases of fire/disaster response.

#### Update on External Missions

- ISCG External Relations Coordinator gave an update on the ongoing Donor Missions and the upcoming SOPs on Missions. The new SOPs will be adopted after it has been issued officially by ISCG secretariat.
- Agencies were reminded that during camp visits no more than two people from each agency should be at each spot.
- Agencies were reminded to report visits to ISCG via using the [mission tracker](#) and by emailing to the External Relations team.
- ISCG requested donors and partners to limit their camp visits during Ramadan and the Eid.
