1. Reviewing action points of the previous meeting

NS coordinators (OIC) lead the review of the September meeting minutes action points.

To check with SARPV who support non- breastfeeding children through locally procured BMS. If SARPV has sufficient stock, BMS support can be extended for UNICEF-funded camps as well.			

- ✓ There will be an ENIM Knowledge dissemination workshop on 8 November 2023. UNICEF is expecting participants from the government stakeholders including NNS, CS, RRRC and representatives from each partner. Lalan will share a draft invitation with NS IMO to share with partners for the nomination.
- ✓ NS is planning to have IM workshops where all the reporting format and guideline will be reviewed and revised if needed. The members agreed to have one representative from each organization and have at least two meetings with them before the workshop in mid-December 2023. The initial meeting date is 5 November and 19 November 2023. NS IMO will invite representatives for this meeting.
- ✓ SARPV confirmed that they don't have stock of BMS for non-breastfeeding children. NS coordinator requested UN partners to have a meeting on this issue and check what is possible from Nutrition. On the other hand, NS will liaise with MSF. It was also recommended that SARPV will handover properly these non-breastfeeding children and any stocks to UNICEF new IP.
- ✓ A SOP on BMS for the non-breastfeeding children needs to be created by NS discussion with the Child Protection sub-Sector.

2. IM update as of August

- √ NS IMO presented programme data analysis from January to September 2023.
- √ The SAM and MAM admission has increased from August. In fact, both SAM and MAM enrollment is the highest in September compared to 2021 and 2022. One of the reasons that partners confirmed for this increase is the screening during deworming campaigns in August.
- √ The average ALOS has decreased and AWG has increased in both SAM and MAM programmes than August 2023.
- ✓ NS IMO will check with every partner regarding the IYCF and IFA achievement. He will send detailed analysis to all the partners asking them to recheck and confirm how they reported.

3. Update from TWGs (5 min each).

AIM TWG update

- √ The SENS survey training started from 22 October 2023 with survey supervisors from each implementing partner and representatives from each UN partner.
- ✓ Two surveys instead of three will be conducted because of the limitations of SENS protocol of max 45 clusters. Two register camps will be considered under one survey while the whole Mega camps will be considered another. This has been discussed and decided in the AIM TWG proposed by UNHCR.

• IYCF TWG update

- ✓ PIN target for IYCF and C-MAMI indicators has been finalized and shared with all members.
- ✓ Meeting with HI and UN partners on Stimulation therapy for Malnourished children will be arranged by 1st or 2nd week based on participants availability.
- √ Home fortifications with the MNP strategy document have been circulated to members for opinions.
- ✓ NS will discuss with UNICEF regarding Non breastfeed children management in UNICEF managed camps.

4. Presentation on WASH Assessment Analysis

- √ The analysis of WASH Assessment that was conducted in July 2023 at INF and SC presented at this meeting.
- ✓ As 1/3 of the water sources at INF/SC are not tested yet, so partners were requested to
 discuss with their respective camp WASH partners regarding the water test. If partners face
 any challenges, then they can request to NS so that NS can liaise with WASH Sector.
- ✓ Partners ask about more details and NS IMO will send the presentation with the data to partners for their actions.

5. Update on 2024 JRP

- ✓ Updated timeline and the DRAFT project template of 2024 JRP were presented for any feedback/concern. There was no feedback for the project template but UNICEF want to review the activity details. NS IMO will discuss bilaterally with Zahid to adjust the Activity details.
- √ The PIN and Target calculations for 2024 JRP were also presented after adjusting all the comments from partners. IYCF TWG will share their updated counseling target based on the discussion today.

8. AOB

INF Opening and Closure Time at Camps

- ✓ There was no harmonized opening and closing hour for INF. So, as per the SAG guidance, a voting poll was created for partners to vote for a suitable time.
- ✓ Maximum (3 out of 5) implementing partners were voted from 8.30 AM to 4.00 PM, as the beneficiaries normally started to come at around 9.00 AM and all staff needs to leave the camp before 4.00 as per RRRC guidelines.
- ✓ So, all the partners agreed to open the INF at 8.30 AM and close at 4.00 PM. However, the nutrition services will be provided from 9.00 AM to 3.30 PM.

GBV Safety Audit Report

✓ GBV Safety Audit at INF/SC is now under the review process of GBV sub Sector and Nutrition Sector. √ NS is liaising with GBV sub Sector to finalize the report as soon as possible. Once it's
finalized, NS will share the report with all partners including actions points for each partners
if any.
