Key Discussion Points:	Action points
<p><b>1. <u>WBW celebration 2024</u></b></p> <p>In a WBW celebration planning meeting initiated by WFP on 14<sup>th</sup> July, the implementing partners had a brainstorming session and came up with some event ideas which then mutually decided that each implementing partner will share the one pager SOP of activity modality of 1 or 2 specific activities. This initiative provided significant time for the partners for finalizing the events. In TWG meeting, WFP presented all the draft SOPs prepared by implementing partners regarding the WBW celebration and TWG members provided their valuable feedbacks on the drafts. WFP requested partners to share 1 or 2 pictures of each events by 15<sup>th</sup> August to facilitate WFP in preparing the WBW celebration fact sheet. Members recommended that partners should have flexibility on which events will be feasible for them to arrange.</p> <p>WBW banner design for the camp setting was presented by IYCF TWG. <p><b>2. <u>Training plan and schedule discussion of HI Stimulation Therapy (AOB)</u></b></p> <p>HI presented their plan of a half day orientation regarding HI Stimulation Therapy for malnourished children (ST-MC) activity and referral pathway in 2 batches for the nutrition service providers working in the ST-MC piloting areas. Each batch will cover 20 participants including Nutrition site supervisors, CMAM Nurse, IYCF Counsellors, ECCD &amp; PSS counsellor and field operation managers. Members recommended HI to share all the operational guideline and tools of ST-MC and training contents with TWG before conducting the orientation. HI was also requested to share the ToR of the service providers of ST MC to understand how the SAM/MAM cases can be benefitted better from bridging with ECCD and PSS Counsellor of nutrition facilities.</p>	<ul style="list-style-type: none"> <li>• HI will share operational guideline &amp; service tools of existing ST-MC piloting and ToR of HI ST-MC service providers with IYCF TWG by 10<sup>th</sup> August.</li> </ul>
<p><b>3. <u>Review of IYCF-E Intervention Review Workshop recommendations and Action plan preparation</u></b></p> <p>The recommendations of IYCF-E review workshop were presented in details. Members suggested making a task force including all implementing partners and UNHCR to work on training modules and presentation. TWG will share the link containing existing modules and PPTs among the task force members. UNICEF is conducting KABP Analysis on SBC barriers (long term recommendations) and UNICEF C4D will share job aid package for the RR context.
