#### **1.** Review of the action points from the previous meeting

#### 2. Infant at risk (<6 months): finalize indicators under CMAM for 2025

Considering the recommendations from WHO 2024 guidelines, all children under 6 months should undergo assessments for malnutrition and provide support as per need. They should be monitored until they become 6 months. To address this, new approach has been taken. From 2025, there will be another nurse in the integrated nutrition facility who will assess these children along with providing support to the Pregnant Breastfeeding Mothers. Discussions took place regarding the indicators for this adapted service. CMAM TWG agreed on two indicators, to conduct rapid assessment for all <6 months children every month and based on the need, they will be assessed in-depth to identify any complication. Based on the identification of the



services required, they will be referred to the particular service point e.g. IYCF corner, PSS corner for the support to the mothers, SC for any medical complication.

## 3. Update from all partners on piloting WHO recommendations – progress, challenges (including home visit checklist)

A brief update was shared on the ongoing WHO piloting. The piloting will continue till October 2024. In terms of supporting the analysis, UNICEF agreed to support. For the analysis, it was decided to collect information from one controlled camp for each scenario. A new version of the database file will be shared soon.

# 4. Update from all partners on piloting WHO recommendations – progress, challenges (including home visit checklist)

In the last meeting, TWG members reviewed the criteria for under 6 months and Stabilization Center which have been incorporated in the guideline. The TWG members will review the guideline further and share feedback in the next meeting to discuss on the remaining sections.
