#### **Discussion on Action Points-**

- ✓ The approach for implementing the Child Functional Module at the community level will be discussed and finalized during the next Nutrition Sector Coordination meeting. Partners highlighted the need for volunteer orientation as a key requirement.
- ✓ The recording and reporting tools have been prepared, and a reporting guideline is currently under development. Both the tools and guideline will be reviewed by SAG for finalization, after which the finalized versions will be shared with all partners.
- ✓ A one-pager on IFA consumption and blanket distribution has been shared with UNICEF for review. Once finalized, it will be disseminated to all partners for implementation in INF.

# **Update from TWG**

### CMAM TWG

- ✓ Recommendations of WHO guideline piloting is ongoing and will continue till December 2024 until all children are discharged from the program. The admission of beneficiaries was completed till October'24.
- ✓ CMAM TWG will arrange a workshop on reviewing the available tools and set an SOP for the management of under 6 months children on 23 December 2024. This workshop will be held alongside the CMAM TWG monthly meeting on the same day.

#### IYCF TWG

- √ The one pager for IFA consumption and blanket distribution is developed and shared with UNICEF for review and finalization.
- ✓ The Health Sector (HS) has developed a Maternal Child Health (MCH) Card as part of a joint initiative. This card includes sections on nutrition, such as GMP and ECCD, and has already been launched. Beneficiaries will carry the card across all facilities. To ensure proper use, a 3-hour orientation session for Nutrition Service Providers will be held in two batches on 18 December 2024. The Health and Nutrition teams will jointly conduct the sessions, coordinated through the IYCF Technical Working Group (TWG).

#### AIM TWG

- ✓ A multisectoral inception workshop of NCA was arranged on 28 November 2024. Data collection is ongoing for the quantitative part and will continue until 21 December 2024.
- ✓ The initial technical workshop on NCA, originally scheduled for 7 January 2024, has been rescheduled to 28 January 2024.

### IM update as of November 2024

- ✓ As of November 2024, 89% of SAM target, 81% of MAM U5 and 99% of MAM PLW reached. IFA for PLW and Adolescent reached 70% and 78% respectively.
- ✓ Admission trends for SAM and MAM increased by 15% & 29% respectively in 2024 among children 6-59 months compared to the same period (Jan Nov) in 2023.
- ✓ Out of total 33 camps, 18 camps for SAM have reached over 90% of their annual JRP target as of November where only 9 camps reached up to 90% and more for MAM U5 child admission target.
- ✓ Every month almost 105% of children under 5 receive GMP as well as 98% children are receiving BSFP and Nutrition Sensitive E-voucher Programme (NSEP) as well as 99% PLW are receiving BSFP service. 124% of IYCF target reached as of November.
- ✓ Overall, 104% of SC target reached (50% from NS partners and 54% from MSF).
- ✓ Non-response rate was always an issue especially for children with SAM. From the analysis it has been noticed that only 12 sites out of 45 (27%) have non-response rate less than 5% whereas 14 (31%) have non-response rate over 10%. On the other hand,

for MAM, seven sites (16%) have non-response rate over 3% whereas nine sites (18%) with no non-response rate.

#### AOB

- JRP Update: The Nutrition Sector informed all partners that the JRP documents have been finalized, and the final project for the 2025 JRP has been successfully uploaded to the HPC project module.
- Planning Workshop Update: With support from UNICEF, the Nutrition Sector organized the 2025 Nutrition Program Planning Workshop to collaboratively develop a strategic and actionable plan for 2025 across five key thematic areas. A follow-up meeting is scheduled for 12 January 2025, during which the lead organizations of the five thematic areas will present three to four top priority recommendations from the workshop to guide the focus for 2025.
- Any Challenges or update: NS requested partners to share any challenges/ burning issues till date in the meeting. Partners shared that all issues were already discussed in the meeting.
