	 The sector has convened an ad hoc SAG meeting to discuss immediate needs and medium-term needs (next six months) in response to the US Government Funding Suspension. The first picture of immediate needs suggests gaps in programming for disability and inclusion in some of the camps and prevention activities to mitigate risks of GBV, trafficking and recruitment. The Protection Sector in collaboration with GBVSS, CPSS, ATWG, and HLPWG, organized the Presentation on 2024 Protection Situation on 19 February. The presentation, attended by the RRRC and the Additional RRRC, focused on the protection trends of quarter 4 and overall, 2024, and highlighted the key advocacy points followed by an interactive dialogue. All six Protection Monitoring Partners and key protection actors were present in the event. The Protection Sector published the Concept Note on Existing Mediation- Legal, Peace, and HLP after the Protection SAG had reviewed and endorsed it on 6 February. The Concept Note provides the definition of the three different models of mediation in the camps and clarifies the distinct features among those. The Protection Sector hosted a meeting with the representatives of the eight donors during their mission in Cox's Bazar on 17 February. The donors were briefed about the achievements and challenges faced by the Protection sector including CP and GBV SS in the meeting, an advocacy note was shared by the Sector which was requested by the donors during the meeting. 		
GBV Sector Updates	 Following the fire incidents in Camps 26 and 1W, the GBVSS provided Psychological First Aid (PFA) to affected families, facilitated safe referrals to connect them with services, and distributed 1,120 dignity kits to women and girls. GBVSS convened its Strategic Advisory Group (SAG) meeting, where discussions focused on finalization of JRP 2025, the GBVSS Annual Workplan 2025, GBVSS's role in the Task Teams of the Peace and Security Campaign, and the review of key GBVSS documents, including Terms of Reference (ToR) and guidelines. On January 13, 2025, GBVSS held its Monthly Meeting, where members discussed the development of the GBVSS Workplan for 2025, field-level challenges and potential solutions, and factors contributing to GBV in relation to Housing, Land, and Property (HLP) issues. Both the Case Management Working Group and the Prevention Working Group held their monthly meetings, where they discussed the 2025 Annual Work Plan, provided updates on the contact list, and reviewed the service mapping. The ToRs for the Case Management Working Group and the Prevention Working Group have been revised, along with the Dignity Kit guidance note. The GBV Standard Operating Procedures (SOPs) have been finalized. 	 GBVSS began mapping the impact of the U.S. funding freeze on GBV services across all partner organizations to assess gaps and challenges in service provision. GBVSS collaborated with the GiHA Working Group during their first planning meeting for International Women's Day 2025, contributing to the action planning process. The GBV Sub-Sector (GBVSS) has planned several key capacity-building initiatives to be conducted in February 2025: 1) Training for GBV camp focal points on the GBV coordination mechanism 2)Training for non-GBV actors on GBV core concepts and the referral mechanism 3)Training on GBV SOPs for GBVSS partners.
