## Welcome and Introduction

Kibrom Tesfaselassie welcomed all the participants to the Nutrition Sector SAG meeting on 1 December 2025. Representatives from all the members were presented in the meeting.

### 1. Closure of INF in 2026 and onward.

- Based on the SAG meeting conducted on 18 September 2025, the following items were endorsed by the SAG.
  - Two INFs (1E Site 1, 10 Site 1) were decided for closure,
  - In camp 20 & 20 ext., 1–2 key staff members will remain at each INF for lifesaving services while rotating other staff between these facilities.
- However, the decision remained pending for the taskforce responsible for assessing Camps 3, 4, and 4 Extension, as no consensus was reached during that period. A new taskforce was subsequently established to re-assess these INFs; however, due to competing priorities—including the Health and Nutrition integration, the prioritization exercise, and the JRP process—no meetings were convened.
- Although the TF members of camp 3, 4 & 4 ext. recommend closing only one (camp 3 site 2 INF) out of five INFs, due to the current funding constraints and gap of another one INFs, it was agreed to close another one INF (camp 4 site 2) from the remaining four which was actually proposed by the first TF members.
- So, in 2026, a total of 40 INFs will be operational out of existing 45 INFs keeping in mind the rotational adjustment for camp 20 and 20 ext.
- The UN agencies (UNICEF and WFP), Concern and current implementing partner GK are requested to plan accordingly. Nutrition Sector will support GK for the approval of RRRC and inform CS office regarding this modification.
